

PRIVACY POLICY

CHARMING CHINA is dedicated to protecting consumer privacy. This Policy explains how CHARMING CHINA collects, uses, and discloses information about you when you subscribe to our services and you visit our Web sites. Your use or receipt of CHARMING CHINA® products or services (including our Web sites or interactive applications) constitutes acceptance of this Policy.

This Policy explains our practices in the following areas:

The nature of the Personally Identifiable Information we collect about you and the way such information is used.

The nature, frequency, and purpose of any disclosure of Personally Identifiable Information that we may make, including the types of persons or entities to whom the disclosure may be made. The period of time for which we maintain Personally Identifiable Information. How you may obtain access to and correct any Personally Identifiable Information about yourself. Your rights under the Communications Act, 47 U.S.C. § 338(i). You may also purchase or use products or services provided by other companies that may be delivered through your CHARMING CHINA Receiving Equipment. Please contact or visit the Web sites of the providers of those products or services to obtain copies of their privacy policies. I. Types of Information we collect and how we collect it

In discussing the types of information we collect from subscribers, users of our interactive services and applications, and visitors to our Web sites, it is important to distinguish between two categories of information. We use "Customer Information" as a broad, general term that refers to any information relating to you or your CHARMING CHINA service, including Account Information, Service Information, Anonymous Viewing Information, Diagnostic Information, Commerce Information, and Interactive Service Information. These terms are defined in more detail below in Section A. We use the term "Personally Identifiable Viewing Information" to refer to information about your personal viewing habits that we collect only with your express consent. This term is defined in more detail below in Section B.

A. The following are specific types of Customer Information that we collect from subscribers, users of our interactive services and applications, and visitors to our Web sites:

"Account Information" means information about your CHARMING CHINA service account, including, but not limited to, your name, address, social security number, e-mail address, telephone number, what programming packages you subscribe to and programming purchases and downloads you make, consumer credit reports, the model and serial number of your CHARMING CHINA Set Top Box or other device authorized to access CHARMING CHINA programming or services (an "Authorized Device"), and privacy preferences. Account Information does not include any Personally Identifiable Viewing Information or Anonymous Viewing Information, as defined below. We collect Account Information directly from you when you activate or change your service, as well as from third parties, such as consumer reporting agencies and consumer data companies. We may combine information we obtain from third parties with Account Information we collect.

"Service Information" means information necessary for us to provide service to your CHARMING CHINA Set Top Box or to enable your Authorized Device to access CHARMING CHINA programming or services. Examples of Service Information include the hardware configuration of your Authorized Device, your CHARMING CHINA Set Top Box's software version number and the success status of the last attempted service calls by your CHARMING CHINA Set Top Box.

"Anonymous Viewing Information" means information about use of your CHARMING CHINA Set Top Box, CHARMING CHINA interactive application, or Authorized Device that is not associated with or linked to your Account Information. For example, your CHARMING CHINA Set Top Box regularly sends Anonymous Viewing Information to us. This information allows us to know, for example, that a subscriber from a particular city watched a show, but we cannot associate those viewing choices with you. Also, if you use a CHARMING CHINA interactive application on an Authorized Device with location-based features enabled, we collect and use precise location data provided by the Authorized Device to customize certain programming and service options available to you through the interactive application. This location data does not personally identify you, but it does provide the real-time geographic location of your Authorized Device. You may request that we block the collection of Anonymous Viewing Information from your CHARMING CHINA Set Top Box as described in Section IV below. Because CHARMING CHINA does not control the hardware and software of the various Authorized Devices you may use to access CHARMING CHINA programming or services, it may not be possible to block collection of Anonymous Viewing Information from all Authorized Devices.

"Diagnostic Information" means detailed information about the operation of a CHARMING CHINA Set Top Box, a CHARMING CHINA interactive application or an Authorized Device. We collect Diagnostic Information logs for a few randomly sampled CHARMING CHINA Set Top Boxes for quality control and troubleshooting. These logs identify your CHARMING CHINA Set Top Box and are thus associated with your CHARMING CHINA service account.

"Commerce Information" means Personally Identifiable Information that enables a commerce partner to fulfill your request to participate in a promotion or transaction. From time to time, we may present on-screen offers or enable you to buy goods and services from us or third parties. Only if you take advantage of such an offer or engage in a transaction, will we collect and send on your behalf information such as your name and address and your interest in a specific offer or transaction to the sponsor of the promotion or transaction. In addition to fulfilling your request, that commerce partner may also use your Commerce Information to send you other information in which you might be interested consistent with its own privacy policies.

"Interactive Service Information" means information collected and stored on our servers when you become a registered user of, or visit, our Web sites or when you use an Authorized Device (such as a mobile phone) to register, log into, or access your CHARMING CHINA service account. We may collect information that you provide us in this manner (including your e-mail address) and use it in accordance with this Privacy Policy. Whether or not you are a CHARMING CHINA subscriber, we may collect information about visitors to our Web sites and users of our interactive services and applications as follows:

Cookies and other technologies: Our Web sites, interactive services and applications, and email messages may use cookies, e-tokens and other technologies. These technologies help us better understand user behavior, tell us which parts of our Web sites people have visited and which features of our interactive services and applications are used, and control access to certain CHARMING CHINA programming and services by identifying personal preferences and equipment configuration of Authorized Devices. We also use these technologies to deliver advertisements in our interactive services and applications that relate to your interests and to measure the effectiveness of ad campaigns. These technologies remain on your computer or other Authorized Device and are automatically retrieved when at a later time you visit our Web sites or access a CHARMING CHINA service or application using that same Authorized Device. These technologies contain only information concerning the type of customer (such as subscriber or visitor), authorized CHARMING CHINA programming and services, and frequently visited pages. No other Customer Information is stored in these technologies. If you are uncomfortable with these technologies, you may disable them on your Authorized Device. Disabling cookies may affect Web site functionality but the design of our Web sites allows access to most offerings with cookies disabled. Visitors who have disabled cookie processing, however, won't be able to use CHARMING CHINA's personalized account management function. In addition disabling cookies or other technologies an Authorized Device may restrict the CHARMING CHINA services that can be accessed from, performed by, displayed on or linked to through that Authorized Device.

Aggregate information about Web site visitors: We create aggregate reports of visitors to our Web sites to measure the performance of our sites. These reports do not contain Customer Information.

Aggregate information about interactive services and applications: We create aggregate reports of users of our interactive services and applications to measure performance and for quality control and troubleshooting purposes. These reports contain Diagnostic Information. If you have logged into your CHARMING CHINA account when using one of our interactive applications, the Diagnostic Information is associated with your CHARMING CHINA service account, and therefore certain reports may also contain other Customer Information.

Links to other Web sites: When you visit our Web sites or use our interactive services or applications, you will find many opportunities to link to Web sites of third parties. When you click through to these sites, CHARMING CHINA's Privacy Policy no longer applies. We recommend that you read the privacy policy for any third party Web sites.

B. "Personally Identifiable Viewing Information" means information about the use of your CHARMING CHINA Set Top Box or specific CHARMING CHINA interactive services or applications, if that information is linked to or associated with your Account Information. We do not collect Personally Identifiable Viewing Information unless you give us your express consent to do so. You may choose to consent to CHARMING CHINA's collection of Personally Identifiable Viewing Information by changing your privacy preferences as provided in Section IV below. If you are a subscriber and do not consent to CHARMING CHINA's collection of Personally Identifiable Viewing Information with respect to CHARMING CHINA interactive services or applications, certain programming, features and functions may not be available to you.

II. Use of Customer Information

We use Customer Information to deliver our service to our customers and to understand what our customers want so we can continue to provide a compelling entertainment service at a good value. Specifically, we use Customer Information for editorial, feedback, marketing and promotion purposes, for statistical analysis, for product development and content improvement, to verify customer qualifications to receive our service, to bill for our service and for other related business purposes. We may use Customer Information to deliver within our video service and interactive services and applications advertisements for goods and services that may be of interest to you. We do not use Personally Identifiable Viewing Information to deliver such advertisements.

Expressly allowing us to collect your Personally Identifiable Viewing Information may help us provide you with a compelling entertainment service. It may help us recommend viewing choices and personalize your viewing experience. Also, we may use this information for surveys, audience measurement, and other legitimate business purposes.

As noted above, we do not collect your Personally Identifiable Viewing Information without your consent. Absent your consent, no "tag" is added to the anonymous viewing file transmitted from a CHARMING CHINA Set Top Box to us that would enable us to identify the CHARMING CHINA Set Top Box from which it came. As also noted above, if you are a subscriber and do not consent to CHARMING CHINA's collection of

Personally Identifiable Viewing Information with respect to CHARMING CHINA interactive services or applications, certain programming, features and functions may not be available to you.

III. When we share Customer Information with third parties

We share Customer Information with third parties where it is necessary to conduct a legitimate business activity related to serving our customers, including as follows:

Support services: We share Customer Information with providers of bill processing, technical assistance, debt collection, and other support services. We take reasonable steps to require these third parties to maintain the confidentiality of the Customer Information and require them to adhere to this Privacy Policy.

Third party services: We share Customer Information with third parties in order to coordinate delivery or billing of the services provided by such third parties to your CHARMING CHINA Set Top Box and Authorized Devices, and to deliver advertisements in our video and interactive services and applications. We take reasonable steps to require these third parties to maintain the confidentiality of the Customer Information and require them to adhere to this Privacy Policy.

Affiliated companies: We may share Customer Information with affiliated companies of CHARMING CHINA. If we choose to share data in this fashion, we will require our affiliates to honor this Privacy Policy.

Marketing: We may share Customer Information, including programming purchases, with selected media, entertainment, and other similar service providers, as well as with third parties with whom we offer co-branded or joint products or services. These third parties may use this Customer Information to market products or services to you.

Aggregated and Anonymous Viewing Information is information that does not identify you, and we may disclose aggregated and/or Anonymous Viewing Information and any derived analyses to third parties including suppliers, advertisers, broadcasters, research companies and other organizations, without limitation.

When you elect to participate in a special offer or engage in a transaction with CHARMING CHINA or a third party advertiser or promoter through your CHARMING CHINA Set Top Box or a CHARMING CHINA interactive service or application, we will collect and disclose your Commerce Information, on your behalf, to the party sponsoring or fulfilling the promotion. This information is disclosed only upon your affirmative response to an offer. In addition to fulfilling your request, that party may also use your Commerce Information to send you other information in which you might be interested consistent with its own privacy policies.

Legal requirements: We may share Customer Information or Personally Identifiable Viewing Information with third parties to meet legal requirements, in response to legal

process, or where permitted by law to protect our rights and property, including to combat identity theft or to investigate billing fraud. In most cases where disclosure is being made pursuant to legal process, we will provide you with prior notice of such subpoena or court order so that you have the opportunity to contest in a court proceeding the subpoena or court order.

Sale or transfer of the business: We may share Customer Information with third parties in connection with the sale, transfer, or other assignment of our business. If we are acquired by another company, that company will possess the Customer Information collected by us and will assume the rights and obligations regarding your Customer Information as described in this Privacy Policy.

IV. Your choices regarding our collection and use of Customer Information

The default privacy preferences, to which you hereby consent if you do not request a change to your settings, do not allow us to collect Personally Identifiable Viewing Information, but do allow us to collect, use, and disclose all Customer Information in manners consistent with this Privacy Policy. You may choose to change your privacy preferences to allow us to collect Personally Identifiable Viewing Information. Even though Anonymous Viewing Information does not include any Account Information whatsoever, you may request that we block the collection of such information from your CHARMING CHINA Set Top Box.

You may request not to receive advertisements in our video and interactive services and applications selected for you based on your Customer Information. However, depending on the interactive service or application, you may still continue to receive advertisements that are related to the content on a web page or in a CHARMING CHINA service or application or based on other non-personal information. Your request to not receive advertisements applies only to CHARMING CHINA advertising services and does not affect interest-based advertising from other advertising networks that may have access to your information through other services or applications available on an Authorized Device.

You may opt not to receive communications that we send to you based on your Account Information. If you make this choice, you understand that we will not be able to inform you about any upcoming features, improvements, or promotions regarding your CHARMING CHINA service. In all cases, however, we will collect and use your Account Information (including Service Information) and Diagnostic Information for legitimate business purposes.

V. How long we keep Customer Information

We maintain information about you for as long as we provide service to you, and longer for related business activities. After information is no longer necessary for our business purposes, we destroy the information unless there is an outstanding request or order to preserve the information.

VI. Our do not contact policy

We may, from time to time, contact you by mail, e-mail or telephone to tell you about additional products or services that we or third parties may offer. VII. How we protect the security of Customer Information

We take reasonable steps to protect Customer Information by using security technologies and procedures that limit access to our databases. However, no system is completely secure or error-free. We do not, and cannot, guarantee the complete security of Customer Information.

VIII. Online credit card transactions

We protect the security of credit card transactions on the Internet by using a secure, encrypted Web server. We maintain credit card information collected during transactions in a secure database at CHARMING CHINA for fraud prevention and accounting and billing purposes. Your credit card information is not available to unauthorized parties while in these databases. Stored information from credit card transactions is not released to third parties except in response to a subpoena or court order.

IX. Your access to information and rights under the Communications Act

You may obtain access to information we collect about you and correct any errors in such information by contacting us anytime by phone 1888-800-7808, e-mail service@hanyastar.com or mail CHARMING CHINA Privacy Policy, 11100 Valley Blvd #336, El Monte, CA 91731. The Communications Act, 47 U.S.C. § 338(i), governs our practices concerning the collection and disclosure of personally identifiable information about you. If you believe we have violated the provisions of the Communications Act, you may bring an action for damages, reasonable attorneys' fees, and costs. The CHARMING CHINA Customer Agreement contains our agreement that claims such as these will be resolved by binding arbitration. You received a copy of the Customer Agreement in your first bill. It is also available at www.hanyastar.com.

X. Changes to this Privacy Policy

We reserve the right to change this Privacy Policy at any time. If we make a significant change with regard to our collection or use of information about our customers, we will note on the main page of our Web sites that this Policy has been updated and may take additional reasonable steps to notify you about the new or revised Policy. In most cases, we will attempt to notify you in some form 30 days before the effective date of the change.
